6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2076-11-29, 1:00 PM** at the office of **Lekheshi Municipality**. Bids must be valid for a period of **90 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **as mentioned below** which shall be valid for 30 days beyond the validity period of the bid.
